THE CHRISTMAS STAMPS OF THE UNITED STATES

The Christmas stamps of the United States invite you to visit some our museums. Many of these stamps are reproductions of works of Art of the most famous artists and you can find the originals in The National Gallery of Art from Washington, or Washington Cathedral, or Art Institute of Chicago, or Metropolitan Museum of Art in New York, or North Carolina Museum of Art, etc.

You can see the masterpieces of artists like Raphael, Memling, Sandro Boticelli, Ghirlandaio, Fra Filippo Lippi and many others. By the side of all these works of famous artists from different countries we can also find works American artists like the 'Winter Sunday in Norway, Maine' (see Figure 3) by an anonymous painter of the 19th century; John Copley, one of the best known representatives of the American Historic Schools, a stained glass window at Washington's Cathedral (see Figure 12) etc.

It is only in 1962, that the first Christmas stamp of the United States shows up, it is that of a 'Wreath and Candles', Scott nr. 1205, and it was of a small size. This was followed in 1963 by a stamp of the 'National Christmas Tree' in front of the White House, Scott nr. 1240. In 1964 they came out with four Christmas stamps showing season's plants, and only in 1966 the first religious stamp came out showing a painting of the 'Madonna and Child' by Hans Memling a Flemish artist. The same stamp was reprinted in 1967, but this Christmas stamp was much larger (see Figure 1).

By 1973 we have another change, this time we have two Christmas stamps and not only one. So that each user can use either a Madonna by Raphael (see *Figure 7*), or a Christmas Tree in needlepoint. Since then the supporters of Santa or of Jesus Christ will find a stamp corresponding to their vision of the Christmas night.




